

### Accused: The Hampstead Paedophile Hoax

Channel 4 has commissioned a 1x90' film that tells the shocking story of how a number of parents and teachers at a Hampstead school were accused of being part of a Satanic paedophile ring. The allegations were found to be baseless but the conspiracy theory caught fire online leading to death threats, harassment and abuse - much of which continues today.

The mothers at the heart of this chilling story speak for the first time in this ambitious feature-length documentary, which blends real archive footage and interviews, with lip-sync drama.

The story begins when videos were released online of two children, accusing parents of their friends, and teachers, of leading a paedophilic satanic cult, supposedly headquartered in secret rooms on the school premises.

The story was entirely made up, concocted by their mother's new boyfriend Abraham Christie. But once the fire was lit, it was impossible to put out. The allegations plagued the lives of the accused, footage shows screaming demonstrators chasing a vicar through Hampstead, a US conspiracy theorist flying to London to investigate and even 'rescue' the children, and online threats of kidnap and far worse. Most of this harassment was instigated by a small group of conspiracy theorists and trolls. With the authorities unable to help, it fell on four of the accused mums, and a band of online activists, to gather evidence and build a legal case against their harassers. After 4 years of fighting to protect their children and get justice, they finally got their day in court.

With exclusive audio testimony of the accused mothers at the centre of this story, lip-synced by actors, and interviews from the conspiracy theorists, Emily Turner's film explores the real-world impact of an outrageous online conspiracy theory, exploring the importance of truth and the cost of lies.

The film will be distributed by All3 International.

Executive Producer, Peter Beard said "Emily's film is a remarkable, terrifying and timely tale. The women at the heart of this story have been so brave in letting us tell their incredible fight for justice. Their story shows that any of us could wake up one morning and find ourselves in the middle of an internet conspiracy. The question is whether we'd have the strength to fight back in the way they did."

Shaminder Nahal, Head of Specialist Factual who commissioned the film added: *"Emily Turner and Story Films have made a remarkable film that is so shocking and yet so relatable - asking huge questions about truth, trauma and justice. The courage of the women at the centre of the story is extraordinary, and the impact of their testimony so profound."* 







## Who harasses whom?



Police built a case against me, after I had published court documents of my co-defendant. The case collapsed due to Police mistakes in both our respective situations. But one officer admitted *"We were hoping for a Restraining Order."* 

I signed such an Order as a 'good girl', without realising how it became the basis for getting me into prison for 'harassment'. I was kept on remand, until the maximum sentence was raised from 5 to 10 years. I was given 9. *"You don't even get that for manslaughter,"* said an inmate.

*"There must be somebody high up involved, the way you have been hounded,"* said my barrister. I gave her the book *Blasphemous Rumours* in case she didn't know about SRA.

My co-defendant was smarter: she refused to sign and was dreadfully harassed, but avoided prison. First her license as a pharmacist was taken, then her home with contents stolen, just as some of the ordeals she had to overcome.

- 1. I had a brick through my front door;
- 2. I was verbally assaulted at a bus stop;
- 3. I had my internet cables cut, after we had won our court case;
- 4. I was stalked and my photo appeared on Hoaxtead, but none of my Police reports were followed up.
- 5. I never ever contacted any of the accused;
  - but I was charged with harassing the four mums who are now the stars of the Hoax film.
- 6. I gave a voice to the accusations of two children who were betrayed by their father and by Police;
- 7. Mainstream media were used for character assassination, 'unbelievability' and deniability of SRA before, during and since my imprisonment. I was to become "Britain's worst troll" [Daily Mail 2020]



### Outrageous online conspiracy theory?

## Social Media step in, where Mainstream betrays

- I published media problems already in 2015
- I was lured into interviews by BBC Radio 4 and Tortoise Media before Story Films
- Nobody will ever know who will wake up when: to the Terrible Reality of SRA and the Happy End of its deniability.
- But Truth prevails!

### **Mainstream Media**

The mainstream press has been used before to cover-up criminality: Sir Nicholas Wall published his judgement regarding Vicky Haigh and her daughter in the press before it appeared on the official data base of judgements. It is terrible to read judgements where 'black' is 'white' and 'white' is 'black' and no way of challenging it. Similarly, the press was used by Haringey Council in the case of the Nigerian Musas when they were falsely sentenced to seven years imprisonment.

In the case of the whistleblower kids, the mother, her partner and I are Victims in Exile to avoid imprisonment by secret family courts. In 2006 Harriet Harman MP said in Parliament [see Col 633] that 200 parents a year are imprisoned by secret family courts!

Justice Pauffley published a Press Release with the headline Satanic 'cult' claims dismissed by judge which was picked up by the Daily Mail, The Telegraph and The Guardian. Later the Ham & High ran smear articles. In my view, the purpose was to prepare public opinion for handing custody of the children to their allegedly abusive father.

Furthermore, Barnet Police used the Harassment Act on behalf of the alleged abusers to arrest the mother and me. See Police Raid on the site of Hampstead Research that publishes excellent videos about abusers online.

## Corporate Media Deny, Deflect and Cover Up...

## ...that is the conclusion of Joachim Hagopian's <u>one page summary</u>:

### **Cover-Ups**

**Why would cover-ups** be necessary if there was nothing to hide? Abraham and Ella dreamt it all up, did they?

Actually, this case 'validates' the precedence of patterns of corruption:


The patterns of corruption and cover-up that have been documented in almost all historical cases of high-level organised paedophilia (for example, the Franklin Cover Up in Nebraska USA (John De Camp); A Nation Betrayed also in the USA (Carol Rutz) to name but two well documented cases outside the UK) appear to be apparent in the current case. These allegedly include (but are not limited to)

- the attempt to discredit the victims and/or those who are supporting them;
- the removal of child-victims from a protective care-giver making the victims extremely vulnerable (often resulting in fear-based retractions of the victims),
- threats of serious harm or death to child-victims or their loved ones if they disclose or refuse to retract their disclosures,
- the intimidation of witnesses and activists who can support the case,
- the attempted or successful destruction of evidence,
- the failure to interview key witnesses who can corroborate the allegations,
- the pursuit of the whistle-blowers on spurious grounds rather than investigating the allegations that have been made ...

In this case, first the Police:


- Barnet Police producing 'retraction' videos six days after the children had been taken into care and closing the case eleven days with 'crime not confirmed';
- Metropolitan Police producing farcical grounds of resistance.
